<u>AIRPORT</u>: **DETROIT METROPOLITAN AIRPORT (DTW),** 9000 Middlebelt Rd., Romulus, MI 48174, 734-942-3550. Approximately 30 minutes from the Dental School.

**PARKING:** Free visitor parking is available at the Corktown Campus in our lot at the 2700 Martin Luther King Jr. Blvd. entrance. Campus Security is on-site.

**<u>DENTAL CLINIC:</u>** The clinical portions of the CDCA examination are conducted in the Dental Clinic Building. The dental clinic opens at 6:00 a.m. on the day of each exam. Candidates may enter the clinic building, find their assigned chair and begin setting up their area.

<u>CHAIR ASSIGNMENTS</u>: Chair assignments for CDCA candidates are determined by the Office of Clinic Administration and will be posted in the clinic where the exam will be taken.

<u>ASSISTANTS:</u> The Detroit Mercy School of Dentistry <u>does not</u> supply Assistants for dental CDCA candidates. Assistants must complete and submit to CDCA The Candidate Agreements for the Use of a Chairside Assistant form. This form should be submitted to the CDCA CFE before the start of the exam. Assistants are allowed to enter the clinic area with the candidates to set up. Assistants must wear a picture ID at all times in the clinic.

<u>PATIENTS:</u> The Detroit Mercy School of Dentistry <u>does not</u> supply patients for dental/hygiene CDCA Candidates, nor does it assume responsibility for any problem(s), which might arise secondary to treatment by the candidate. Patients arriving for the exam must wait in the reception area until the start of the clinic portion of the exam. At no time other than during the examination will a patient be allowed in the clinic areas.

#### **INSTRUMENTS and EQUIPMENT**

<u>All</u> clinic units will adapt to electric or air-driven hand-pieces. This system is compatible with the Bien-Air electric or like hand-piece and/or Starlite and Borden high-speed air-driven hand-pieces and Midwest Quicktorque or Titan H air-driven low speed hand-pieces. All units are equipped with a disposable air/water syringe. NOTE: Electric motors are provided in all clinic units.

# **IMPORTANT**

The Detroit Mercy School of Dentistry <u>does not</u> provide instruments (i.e., handpieces, dental cassettes) <u>or</u> shrouds for the Columbia manikin head. Candidates <u>MUST</u> bring own handpieces, instruments, scalers, tips, inserts, shrouds and protective eyewear. Cavitrons are mounted on each chair.

<u>CONSUMABLE/DISPOSABLE MATERIALS:</u> Air/water syringe tips, headrest covers, patient napkins, bracket trays covers, waste receptacles, paper cups, paper towels, gauze pads, cotton rolls, gloves and face masks <u>are provided in the clinic</u>. **<u>REPAIRS:</u>** The Dental School is required to have a repair technician on the premises during CDCA exams. A repair technician from Benco will be available if repairs are needed.

**RADIOGRAPHS:** Candidates are responsible for bringing all necessary radiographs.

<u>STERILIZATION SERVICES:</u> Candidates must supply all sterilized instruments <u>and</u> are responsible for sterilization after the exam. The school does not provide sterilization services when the exam is over, but sterilization bags are available.

<u>CLINIC USER FEE:</u> All non-UDM dental and dental hygiene candidates participating in the CDCA exams must pay a clinic user fee prior to taking the exam.

- Dental exam candidates fee: \$300.00
- Hygiene exam candidates fee: \$175.00
- <u>Cashier's Checks</u> (Bank Check) or <u>Money Orders</u>. Candidates name must be on cashier's check or money order.
- Made payable to the <u>DETROIT MERCY SCHOOL OF DENTISTRY</u>
- PERSONAL CHECKS ARE NOT ACCEPTED (AND WILL BE RETURNED)!!
- The fee must be received prior to the examination date. External candidates will not be allowed to start the exam until the fee has been paid in full.
