ATTENTION CDCA/ADEX CANDIDATE:

Welcome to the Department of Dental Hygiene at BridgeValley Community and Technical College! We are pleased to host the CDCA/ADEX Dental Hygiene examination. The following information is provided for reference only when planning for examination at our site.

Requirements and grading for the examination are determined solely by CDCA/ADEX.

Facility Fee: \$125

BridgeValley Community and Technical charges a \$125.00 facility fee for all candidates. The fee will be billed with the CDCA examination fee.

BridgeValley Community and Technical College provides the following for use by candidates:

Operatory

Each operatory is equipped with a patient chair, operator stool, dental light, writing surface and instrument head/tray. Handpiece conncector is for two hole connection Powered scalers are unit mounted Cavitron brand with wands provided. HVE and Saliva ejector connections are also included

Disposables

Barriers for chair, light and all touch surfaces Surface disinfectant wipes Gauze, cotton rolls, cotton-tipped applicators, saliva ejectors, HVE tips, air/water tips Prophy angles, prophy paste, floss Needle guard cards Patient napkin and disposable holder Operator overgown, mask and nitrile gloves

Anesthetic

Topical Anesthetic Benzocaine 20% gel Cetacaine liquid

Local Anesthetic Carpules Lidocaine 2% with 1:100,000 epinephrine Mepivicaine 3% Plain Bupivicaine .5% with 1:200,000 epinephrine

Local Anesthetic Needles 27 gauge short and long

Candidate must supply:

Candidates are to bring sterile instruments to the examination. Following treatment, autoclave bags and wrap will be available to prepare instruments for transportation back to another site for processing. The BridgeValley CTC Department of Dental Hygiene accepts <u>no responsibility</u> for lost or damaged instruments.. Personnel will be available to assist you in the sterilization area.

Instruments Ultrasonic inserts (wand provided) Handpiece (two hole connection)

Loupes/safety glasses Patient protective eyewear Blood pressure recording equipment Utility gloves for operatory/instrument preparation Disclosing Solution Pens and pencils CDCA/ADEX required paperwork
