

ATTENTION CDCA/ADEX CANDIDATE:

Please note that parking is difficult to obtain in Jersey City. Please arrive early so that you have ample time to find a parking spot. We are two blocks from Journal Square (Path train) and NJ Transit bus stops on Newark Ave in Jersey City.

Facility Fee:

The fee is \$350 this includes use of Eastern International College's instruments. This fee will be paid prior to testing and can be done at the registration session.
