*PLEASE be on time for your scheduled session!*

*If you are scheduled for the morning session you must arrive to the school @ 6am, afternoon session arrive to the school @11am. The CDCA DH Exam and chair assignments are scheduled on the 3<sup>rd</sup> floor of the Dental School.
