ATTENTION ADEX/CDCA CANDIDATE:

It is important that you understand your responsibilities as a CDCA candidate at this testing site. Review the following material thoroughly.

- Candidates are not permitted access to the dental health clinical facility prior to the exam.
- Candidates may not screen patients or take radiographs prior to the exam at the Palm Beach State College dental hygiene clinical facility.
- Unit assignments for the ADEX/NERB dental hygiene candidates are determined by CDCA administration and will be posted the day of the exam.
- Injectable local anesthesia (ILA) is not permitted to be administered at this examination site.
- Exam Date: Wednesday May 13 and Thursday May 14, 2020
- Morning exam session: 6:30 am-7:45 am Registration and set up
7:45 am-12:15 pm Exam
- Afternoon exam session: 11:45 am-1:00 pm Registration and set up
1:00 pm-5:30 pm Exam

FACILITY FEE:

Palm Beach State College is not the administrator of the examination, but has made arrangements with CDCA to provide a site for the examination. The facility fee charged covers the cost and use of the dental equipment and supplies the facility provides for candidates during the exam.

- Palm Beach State College **Dental Hygiene Exam Facility Fee: \$200.00 non-refundable**
- Make cashier check or money order payable to the **Palm Beach State College** and attach to **Dental Hygiene Exam Facility Fee Form**.
- **Candidates must bring payment of the non-refundable Dental Hygiene Exam Facility Fee to Palm Beach State College Cashiers office for payment. Payment must be received prior to your scheduled Exam Date. The paid receipt must be presented on site at check-in, on the date of examination.** If you cannot visit the college site before the exam, please mail payment directly to Cashiers office, specifying the fee is for the Dental Examination. It is your responsibility to **CONFIRM** with cashier office that check was received (before your assigned date to take exam); you will not be able to take exam without showing receipt. **Cashier's Checks and Money Orders only.**
