Injectable Local Anesthesia at Pensacola State College Exam Site

The actual process for the candidate use of ILA is as follows:

- Permission for the use of any anesthetic agent must be granted at the start of the examination and properly documented on the Progress Form.
- Only the candidate taking the examination may administer ILA. Candidates may not utilize staff or other dentists or dental hygienists to perform this task. The candidate may choose not to use anesthetic agents.
- If ILA is **not** going to be used, an appropriate topical anesthetic **must** be documented on the Progress Form whether or not the candidate plans to use topical anesthetic. For this examination, combination agents such as lidocaine and prilocaine periodontal gel 2.5%/2.5% are considered topical anesthetics. If allowed by the examination site,
- the use of ILA is permitted by candidates:

-who are students at the host school and who have successfully completed the required anesthetic course.

-who are student candidates from schools in Florida but external to the school hosting the examination, including unlicensed graduates of schools external to the host school, and who provide a letter from their program director certifying successful completion of the required anesthetic course work.

-who are graduates and who are authorized by Florida to use ILA, and who provide documentation, on the day of the examination, authorizing them to utilize ILA (copies of active state certificates that permit the use of ILA are acceptable documentation).

If using an ILA, the record requires the following information:

- **type(s)** of injection administered, which pertains to either block or infiltration
- **anesthetic(s)** which relates to the generic or brand name and percent used
- **quantity**, record the amount (cc) of anesthetic used
- **vasoconstrictor**, if present, must specify the type and concentration
- **if the patient has previously received an anesthetic the same day**

Example(s):

- Topical Benzocaine 20% and Infiltration, 3% Mepivacaine, 0.6 cc
- Topical Lidocaine 5% and Block, 3% Carbocaine, 1.8 cc (some manufacturers report 1.7cc in each cartridge)
- Topical Benzocaine 20%, and Infiltration, 2% Lidocaine with epi 1:100,000, 0.6 cc

Additional Information:

- Candidates needing more than 2 cartridges during an exam must request these from the Clinic Floor Examiner (CFE) for proper documentation. This protocol must be followed for each subsequent cartridge.
- Anesthetic solution may only be administered following approval of the CFE.
- An aspirating syringe and proper aspirating technique must be used for the administration of local anesthetic. Candidates may be observed for proper technique in order to ensure patient safety and comfort.
- If an anesthetic solution has already been administered for pain control on the same day, this must be noted on the Shared Patient section of the Progress Form prior to check in.
- If ILA is not going to be used, an appropriate topical anesthetic must be documented on the Progress Form whether or not the candidate plans to use topical anesthetic
